## **ASQ Moves to Online Recertification**

Members with certifications will be happy to know that ASQ now has the facility for its members to submit their Recertification Journal online via <a href="https://asq.org/cert/mycertifications">https://asq.org/cert/mycertifications</a>.

You can now log in the Recertification Units (RUs) as you earn them over the three-year period. Your RUs will be stored on your record so, once the Recertification Journal is approved and the record updated, there is no need to keep hard copies any longer. To add, remove, review or adjust the activities on the Journal, you can use the "Edit" button next to the appropriate recertification unit activity type and follow the instructions provided.

When you have logged a minimum of 18 RUs and you are within 6 months of your recertification date, hit the "Recertify Now" button at the bottom of the Recertification page and you will be taken through the process of submitting and paying for your recertification. Your journal will then be submitted to the recertification coordinator for approval. If the recertification coordinator has any questions regarding your credits or documentation, he will contact you. Once submitted, you can check the progress through your "My Certifications" page.

If you wish to synchronize any of your certifications, then you will need to send in your recertification journal, with appropriate documentation, to your section recertification chair or to the ASQ recertification coordinator through mail or an e-mail. You will not be able to use the online journal to synchronize.

The Certified Supplier Quality Professional works with an organization's supply chain and suppliers to continuously improve performance of key system components (increase lifecycle, reduce scrap, improve repair processes) by implementing process controls and developing quality assurance plans. The certified supplier quality professional tracks data, identifies improvement projects, and manages cross-functional implementation to improve performance of key components and suppliers.
